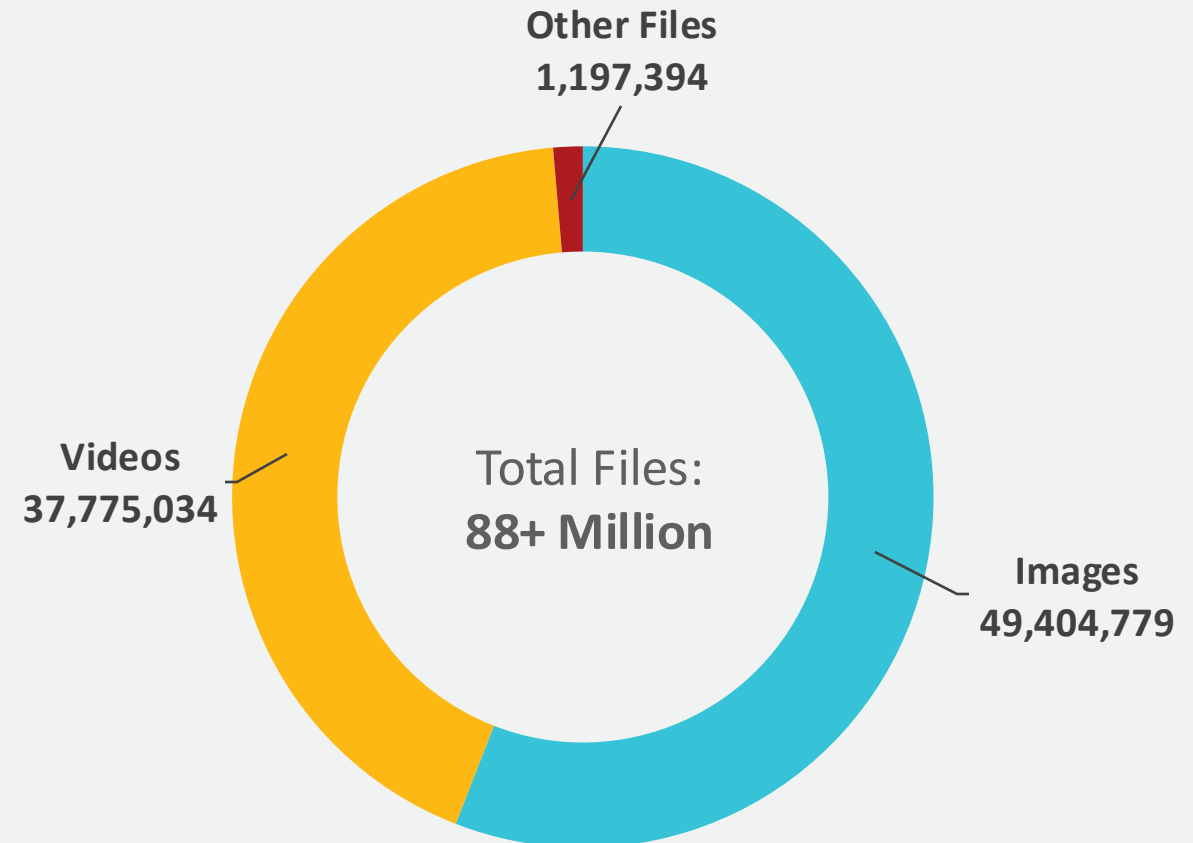




CyberTipline – 2022 Data



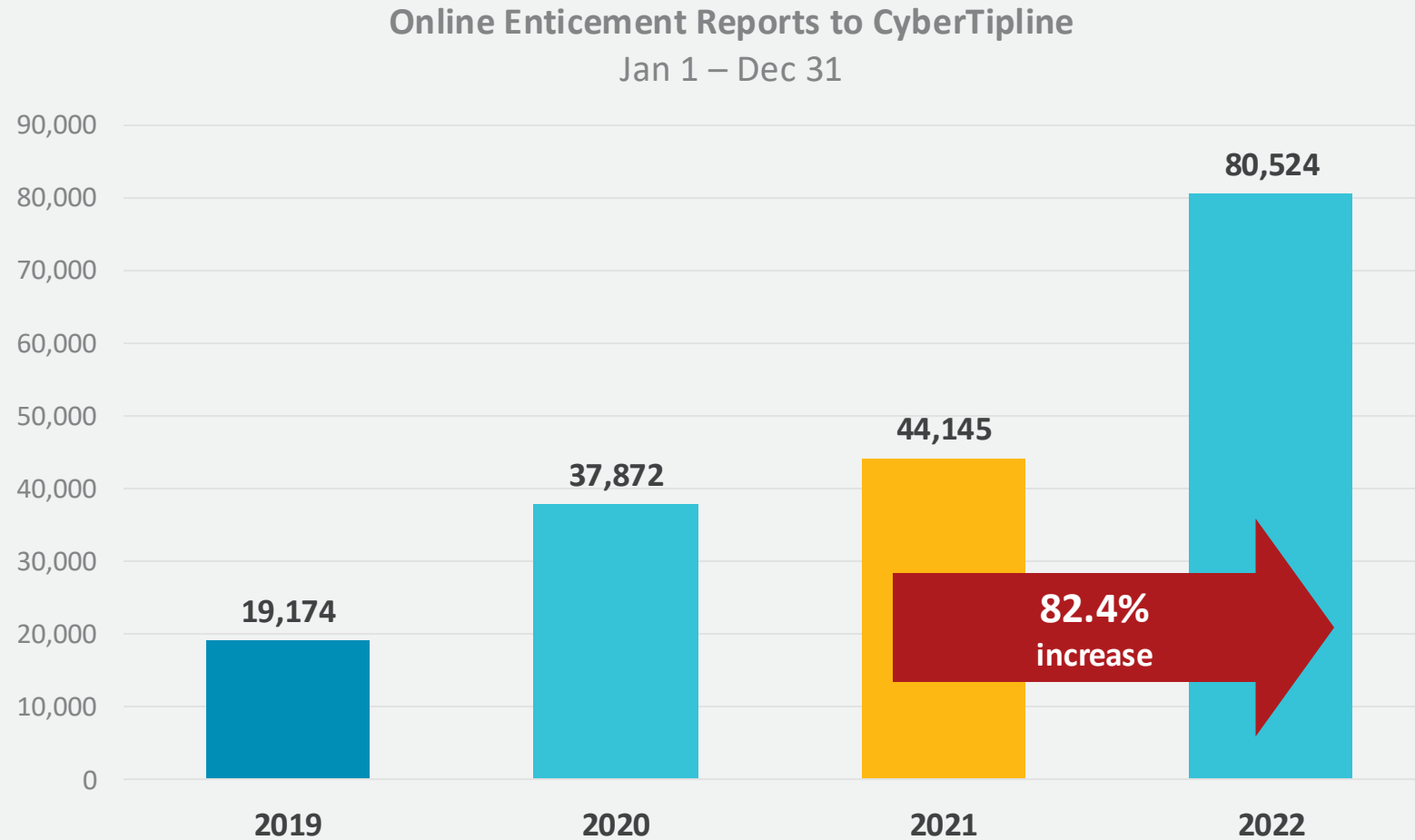
In 2022,

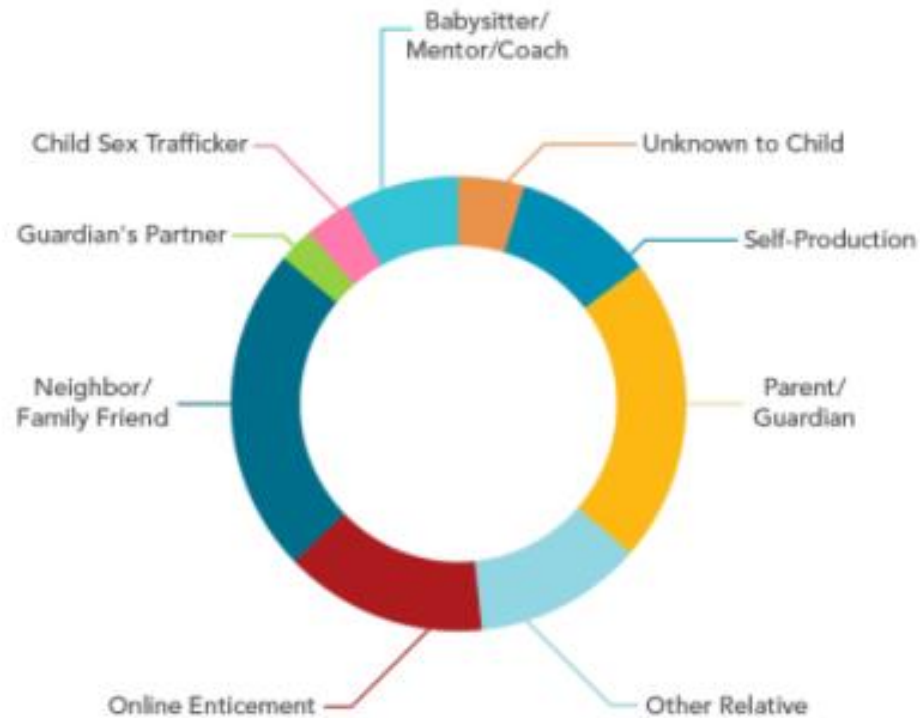
Increase in Reports of Online Enticement

1. Abuser data based upon victim information submitted to NCMEC by law enforcement, The data represent the known relationships from 12,254 series (16,358 identified victims).
2. "Online Enticement" includes either (1) victims who met a perpetrator online and transmitted self-produced images or (2) victims and offenders who met online and then met offline, producing images.
3. "Self-produced" includes those victims who have produced and distributed images of themselves.
4. "Human Trafficker" includes victims of commercial sex trafficking.
5. "Unknown to Child" includes un-established relationships, i.e. photographers, runaways, etc.

1



School Evacuation

Some schools and day cares have emergency plans for a variety of scenarios, but recent studies indicate many do not. If your child's school or day care does not have a reunification plan, encourage them to reach out to their school district or local emergency management agency to discuss developing one.

2



Emergency Calling

Develop and regularly practice emergency plans at home with children and pets in case your family is separated. Designate an out-of-state relative or close friend to become "communications central" for the family. Because local phone lines may be down or inundated in the immediate aftermath of a disaster, someone out-of-state will be best positioned to receive calls.

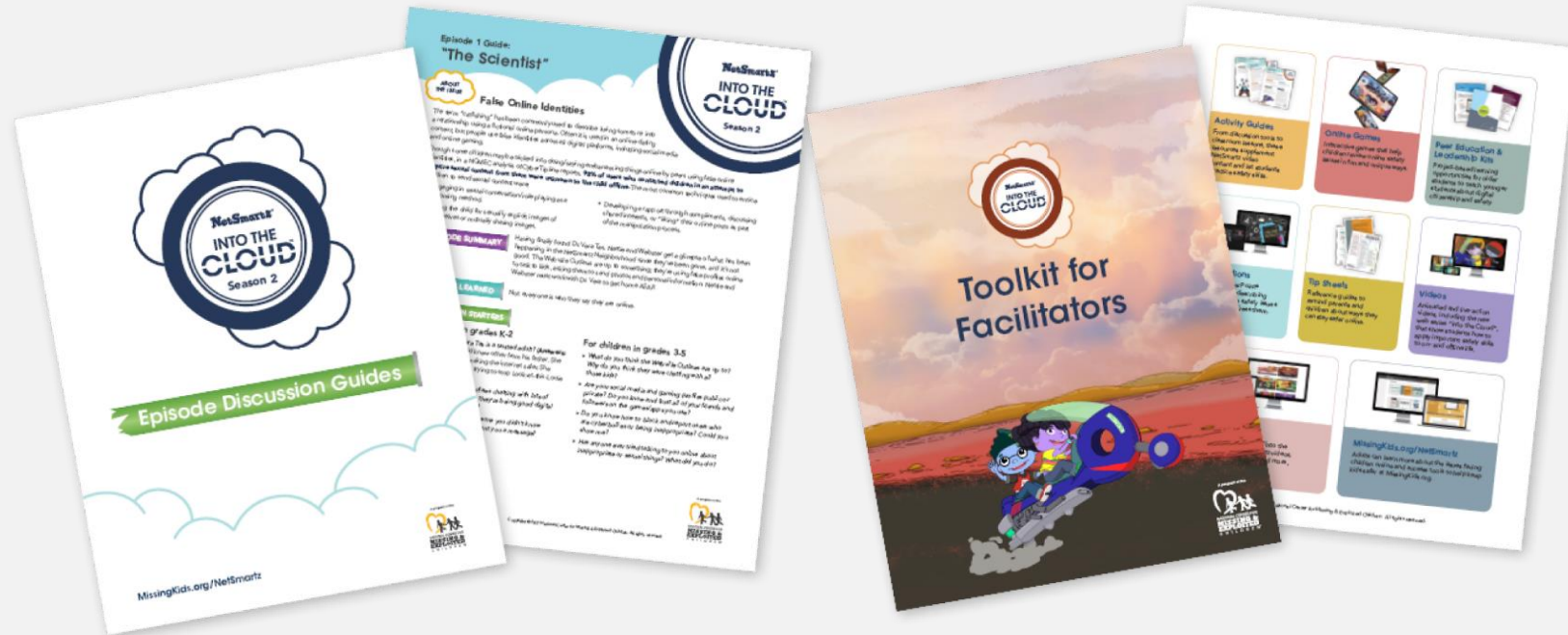
Into the Cloud Web Series

Episode 1 "Enter Badromeda"

After falling into an abandoned tube, Nettie and Webster are carried into a deeper layer of the cloud called Badromeda. They quickly realize that they'll have to put their NetSmartz skills to work by not responding to the taunts and drama of the strange creatures they encounter.

Episode Theme: Digital Citizenship

Episode 2: "TMI"

Nettie and Webster continue their journey and arrive at a museum where a young Badromedan is loudly and visibly sharing personal information. Using their NetSmartz, Nettie and Webster help him understand why privacy is important online.

Episode Theme: Online Privacy

Episode 3: "Rocket Bike"

Nettie and Webster encounter a pair of teens and offer their assistance to help them make better online decisions, like not responding to cyberbullies. They also learn about someone who may be able to help them return home safely, so they hop on a rocket bike and take off in hopes of finding help!

Episode Theme: Cyberbullying

Episode 4: "Fact or Fake?"

An alley full of distractions quickly pulls Nettie and Webster away from their set task. While distracted, they lose their map. When trying to redraw it, they find themselves bombarded by information – some conflicting, some outlandish – and must remember what they know about evaluating information online to find reliable information to recreate the map.

Episode Theme: Misleading Information

Episode 5: "Checking In"

Realizing they were not able to check in with their trusted adult, Clicky, before being transported to Badromeda, Nettie and Webster try to send him a message, but they accidentally end up on a website with upsetting content, which they quickly report. Back in the NetSmartz Neighborhood, Clicky tries to reach Nettie and Webster, but to no avail!

Episode Theme: Inappropriate Content

Episode 6: "Finding Vera"

Nettie and Webster restart their journey with a new map and encounter young rocket bikers whose behavior make the duo uncomfortable. Nettie and Webster report their suspicious behavior to a Badromeda Protection Officer. Then they gather clues in hopes of finding their way home with help from a trusted adult.

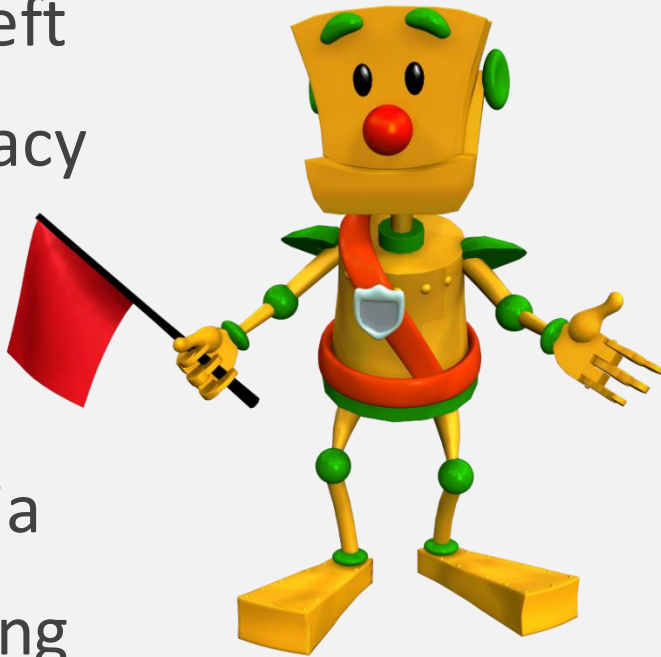

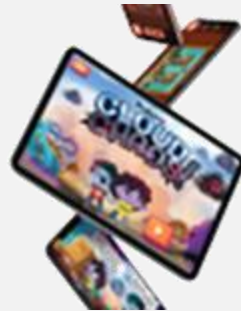

Sextortion

- Red Flags
- Those involved in the sextortion of children often:
- Approach a child on social media after using it to learn about the child's interests, friends, school, family, etc.
- Intentionally move their communications with the child from one online platform to another (e.g., moving from social media to private video chat or messaging apps)
- Use tactics to coerce a child, including:
 - » Reciprocation ("I'll show you, if you show me")
 - » Initially offering something to the child, such as money or drugs, in exchange for sexually explicit photos/videos
 - » Pretending to work for a modeling agency to obtain sexual images of the child
 - » Developing a bond with the child by establishing a friendship/romantic relationship
 - » Secretly recording sexually explicit videos of the child during video chats
 - » Physically threatening to hurt or sexually assault the child or the child's family members
 - » Using multiple online identities to contact a child
 - » Pretending to be younger and/or a member of the opposite sex
 - » Accessing the child's online account without authorization and stealing sexual images or videos of the child
 - » Threatening to create sexual images or videos of the child using digital-editing tools
 - » Threatening to commit suicide if the child does not provide sexual images or videos
 - » Saving sexually explicit conversations with the child and threatening to post them online

Let us help you.

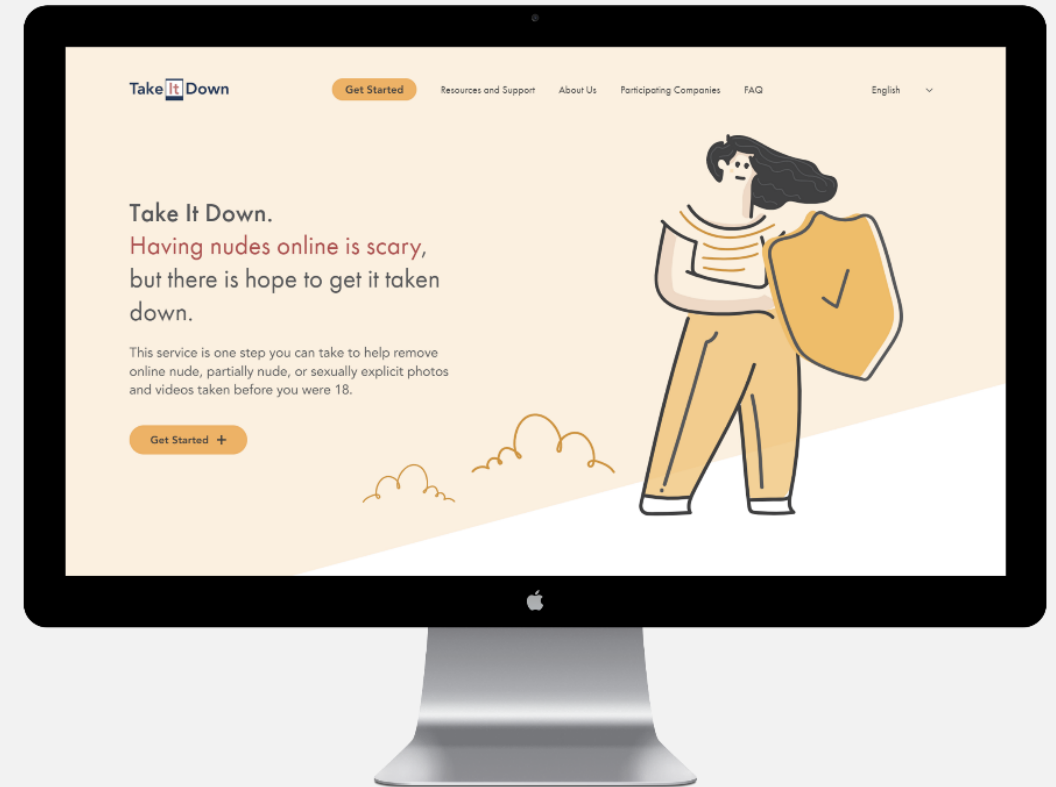

Report (Anonymously) to TakeItDown.NCMEC.org

- Free and anonymous
- Remove or stop the online sharing of nude, partially nude, or sexually explicit images or videos of minors
- For each image or video, a “hash” is generated
- Image/video remains on user’s device
- The hash is added to a secure list maintained by NCMEC
- Only participating companies will have access to the hash



TREND: Sextortion

The average age approximately 14 years old; age range: 8-17

In 22% of the reports, the reporter mentioned being suspicious of, or knowing that, multiple children were targeted by the same offender.

Child victims self report

- Directly through Cybertipline
- Indirectly through ESPs



A revealing image may:

- Get lost or misplaced
- Be passed around without your permission
- Be used to bully you
- Be used to blackmail you
- Get you in trouble





What Now?

- File a complaint
- Include your age
- Tell them it was posted without your consent

TRENDS: Who Is At Most Risk?



- Poverty & Experience of homelessness
- Prior victimization
- Lack of local community support
- Cultural, gender or sexuality differences
- Substance use/abuse
- Differently abled
- Prior child welfare or juvenile justice involvement
- Access to technology but minimal parental oversight
